Suraj caught me yesterday and we decided that the best response would be to get the landowners arb consultant to inspect the trees, come up with a scheme of ameliorative work and put in a TWA.

It was felt that this was unlikely to be something we would prosecute but, because the damage was low down on the canopy (and hence shaded and unlikely to re-grow) and because the cuts, though clean, had not necessarily all been made to growth points, further work may be required. If required it should be applied for an approved in the normal way.

Apologies for my delayed response. I would normally include my recommendation as a condition of consent (as below) within the Decision Notice if, for example, the proposed work specification is vague and needs to be tightened to remove any ambiguity and risk of excessive works being carried out:

- Crown Lift trees to 3m above ground level.
- The Council considers the proposed crown lift acceptable on the condition that pruning is restricted to the tip reduction of minor tertiary and secondary branch ends only to create some vertical lift of the tree canopy to 3m above ground level and must avoid the removal

of main structural branches and branches in excess of 70mm in diameter back to the main stem.

However, the applicant can now submit the above as their work specification. These works would need to be submitted to the Council within a formal tree works application and written consent given before any works are carried out. I hope this clarifies things but if you have any further queries, please don't hesitate to contact me.

From the documents and photos provided it appears the larger diameter branch that was reduced was dead and/or decayed and the majority of the remaining pruning was of small diameter secondary/tertiary growth to provide adequate lower crown clearance which would normally be given consent.

The recommended works within the arboricultural report to crown lift the trees appears to be reasonable and consent would normally be given on the condition that pruning is restricted to the tip reduction of minor tertiary and secondary branch ends only to create some vertical lift of the tree canopy to 3m above ground level and must avoid the removal of main structural branches and branches in excess of 70mm in diameter back to the main stem.
