Title attributed to the contract by the contracting authority: UK-Central Berkshire - Waste Management Services.

The councils wish to appoint a contractor to provide an integrated long-term service for the reception, recycling, composting, treatment and disposal of household and, potentially, other municipal waste from the 3 councils' administrative areas. The councils seek continual improvement in line with the principles of best value and the contractor will be expected to meet and exceed statutory recycling and diversion targets. The councils have secured financial support for the scheme under the United Kingdom Government's Private Finance Initiative. It is one of the conditions of the provision of PFI credits that these targets are exceeded.

- 3. **Delivery to:** Central Berkshire area which comprises the administrative areas of Bracknell Forest Borough Council, Reading Borough Council and Wokingham District Council. NUTS code: UK 521 Berkshire.

- 5. **Division into lots:** The councils wish to optimise the value for money of the project. For this reason, part of their evaluation will focus on the cost of certain elements of each bid. The councils' preference is to award one contract but, in order to achieve optimum value for certain elements, they reserve the right to propose preferred sub contractors or otherwise require the contractor to obtain better value. The ISOP/ITN will include further details.

- 8. Time limits for completion or duration of the contract, for starting or providing the service: Service commencement anticipated for late 2004. Duration of contract will be long term in the region of 20/30 years.

There are collection contracts currently in place with each council separately and tenderers will be required to explain how this interface can be managed in the short, medium and long terms. At the expiry of existing contracts, or earlier if appropriate, one or more of the councils may wish to explore the possibility of integration of collection services into the main contract.

The combined annual tonnage of household waste will vary accordingly to waste and population growth. The current combined tonnage of household waste is in the order of 210 000 tonnes per annum.

This notice is issued in compliance with the Environmental Protection Act 1990, Landfill Directive 2000 and Waste Strategy 2000.

The councils will award the contract on the basis of the most economically advantageous tender. The evaluation criteria will be set out in the ITN. The councils reserve the right to stop the procurement at any time during the process, which shall include the right not to award the contract.

It is intended at the start of the negotiation stage to invite pre-qualified candidates to submit outline proposals (ISOP stage).

The councils may, subject to the duty to obtain 'best consideration' under section 123 of the Local Government Act 1972, offer certain council-owned sites for use on this contract. Tenderers are also free to propose their own as alternatives or in addition to any council-owned sites. Further information, including title information will be provided in the ITN as appropriate.
