

# **ROAD TRAFFIC REGULATION ACT 1984**

## **WOKINGHAM BOROUGH COUNCIL**

**(A4 LONDON ROAD, LONDON ROAD, THE DRIVE AND WHITEGATES LANE, EARLEY)**

### **(TEMPORARY PROHIBITION OF STOPPING AND WAITING) ORDER 2025**

WHEREAS the Wokingham Borough Council ("the Council") as Traffic Authority is satisfied that traffic on the said roads should be restricted by reasons of maintaining the safety of the public.

NOW THEREFORE the Council in exercise of its powers under Section 14 (1) (b) of the Road Traffic Regulation Act 1984 and all other enabling powers HEREBY MAKES the following Order:

1. This Order shall come into operation on 11<sup>th</sup> July 2025 and shall be cited as the WOKINGHAM BOROUGH COUNCIL (A4 LONDON ROAD, LONDON ROAD, THE DRIVE AND WHITEGATES LANE, EARLEY) (TEMPORARY PROHIBITION OF STOPPING AND WAITING) ORDER 2025
2. Save as provided in Articles 7 and 8 hereof, no person shall cause or permit any vehicle to stop or wait at any time in A4 London Road, Earley in the stretch of A4 London Road which bisects the perimeter of the Suttons Seeds roundabout.
3. Save as provided in Articles 7 and 8 hereof, no person shall cause or permit any vehicle to stop or wait on Friday between the hours of 11:00 and 15:00 in London Road, Earley (residential section) from its junction with A4 London Road westwards for its entirety.
4. Save as provided in Articles 7 and 8 hereof, no person shall cause or permit any vehicle to stop or wait on Friday between the hours of 11:00 and 15:00 in The Drive, Earley (north-east side) between the property numbered 5 and existing bus markings outside property numbered 49.
5. Save as provided in Articles 7 and 8 hereof, no person shall cause or permit any vehicle to stop or wait on Friday between the hours of 11:00 and 15:00 in The Drive, Earley (south-west side) between property numbered 18 and property numbered 30.
6. Save as provided in Articles 7 and 8 hereof, no person shall cause or permit any vehicle to stop or wait on Friday between the hours of 11:00 and 15:00 in Whitegates Lane, Earley (north-east side) between its junctions with Eleigh Court Drive and Culver Lane.
7. The restrictions contained in Articles 2 to 6 hereof shall not apply to any vehicle being used in the service of Police, Fire or Ambulance services or proceeding at the direction of a police constable in uniform or for any purpose in connection with the execution of statutory works or for vehicles being used in connection with a wedding or funeral.
8. The restriction contained in Articles 2 to 6 hereof shall only apply during such periods and to such extent as indicated by traffic signs complying with the Traffic Signs Regulations and General Directions 2016 when lawfully displayed in the said roads.
9. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament
10. This Order shall come into operation on the 11<sup>th</sup> July 2025 and shall continue in force for a period not exceeding 18 months.
